<sup>1</sup>Wetlands are identified and delineated using the methods and criteria established in the Corps Wetland Delineation Manual (87 Manual) (i.e., occurrence of hydrophytic vegetation, hydric soils and wetland hydrology).

<sup>2</sup>The term "adjacent" means bordering, contiguous, or neighboring. Wetlands separated from other waters of the U.S. by man-made dikes or barriers, natural river berms, beach dunes, and the like are also adjacent.

RATIONALE FOR THE BASIS OF JURISDICTION DETERMINATION (include connections to downstream navigable waters; document navigability and/or interstate commerce connections; for Adjacency Determinations, must include description of waters/wetlands distance from and elevation above other waters and any uplands between wetlands/waters and other waters):

**Wetlands on property are adjacent to Lake Huron, a navigable water, and the mouth of the Black Mallard River which is under direct influence of Lake Huron to an elevation equal to the lakes ordinary high water mark (OHWM) of 581.5 ft IGLD 1985. The wetlands are either directly connected to the waterway or separated by narrow upland berms that exhibit strong seepage connections through the berms as well as showing evidence that during periods of high spring water (following snow melt) that water also moves via sheet flow from one wetland to another.**
