**Jurisdictional Determination (JD):**

<sup>1</sup>Wetlands are identified and delineated using the methods and criteria established in the Corps Wetland Delineation Manual (87 Manual) (i.e., occurrence of hydrophytic vegetation, hydric soils and wetland hydrology).

<sup>2</sup>The term "adjacent" means bordering, contiguous, or neighboring. Wetlands separated from other waters of the U.S. by man-made dikes or barriers, natural river berms, beach dunes, and the like are also adjacent.

**RATIONALE FOR THE BASIS OF JURISDICTION DETERMINATION** *(include connections to downstream navigable waters; document navigability and/or interstate commerce connections; for Adjacency Determinations, must include description of waters/wetlands distance from and elevation above other waters and any uplands between wetlands/waters and other waters):*

Wetlands on the site are adjacent to and feed the intermittent stream flowing north. The intermittent stream is part of the tributary system of the Main Beaver Dam Ditch which is part of the tributary system of the Little Calumet River, a navigable water of the U.S. Portions of the intermittent stream have been placed in subsurface tiles for agricultural purposes.
