Site Conditions: The site was wooded and there was a mix of wetland and upland at the time of the inspection.

Rationale to Determine No JD. The applicant was able to show that the site historically flowed to a larger wetland area that was previously determined to be isolated. Approximately 1.07 acres of isolated wetlands were present.
