#### **A. TNWs AND WETLANDS ADJACENT TO TNWs**

Summarize rationale supporting determination: The North Channel of the St. Clair River is on the Detroit District's list of navigable waters. The review area is adjacent to the North Channel of the St. Clair River, a navigable water of the United States. The North Channel of the St. Clair River has historically been used, and is used today, as a recreational and commercial waterway transporting people and goods to and from other states as well as around the world. The river and its adjacent wetlands provide invaluable nursery area and habitat for waterfowl and fisheries. It is a Section 10 waterway and any work in it, or its adjacent wetlands, requires a USACE permit.

##### **2. Wetland adjacent to TNW**

Summarize rationale supporting conclusion that wetland is "adjacent": Wetlands WC13, WC18, WC21, WC38, and WC44, are adjacent to and contiguous with the North Channel of the St. Clair River. Although separately labeled, these wetlands are all part of one contiguous system that continues onto offsite areas. These wetlands are located at or waterward of the Ordinary High Water Mark (OHWM) of the St. Clair River, which is coincident with 573.6 feet (IGLD 1985) elevation contour on the shore and are remnant evidence of multiple historic river channels within the St. Clair River delta in this location. Evidence of the remnant river channels are observable on various aerial photos submitted by the consultant. Waters onsite still provide functions and values necessary to maintain the physical, chemical and biological integrity of the North Channel of the St. Clair River and Lake St. Clair.

#### **B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):**

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody<sup>4</sup> is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The wetland boundaries were field verified on April 21, 2014 and November 13, 2014. Wetlands identified as WC13, WC18, WC21, WC38, and WC44 are in fact all part of one wetland system adjacent to the North

Channel of the St. Clair River. Wetlands WC13, WC18, WC21, WC38, and WC44, are adjacent to and contiguous with the North Channel of the St. Clair River. Although separately labeled, these wetlands are all part of one contiguous system that continues onto offsite areas. These wetlands are located at or below the Corps' OHWM elevation and are remnant evidence of multiple historic river channels within the St. Clair River delta at this location. Evidence of the remnant river channels are observable on various aerial photos including multiple historic aerial photos in the DTE Aerial Photo Collection at Wayne State University. Waters onsite still provide functions and values necessary to maintain the physical, chemical and biological integrity of the North Channel of the St. Clair River and Lake St. Clair. The river and its adjacent wetlands provide invaluable nursery area and habitat for waterfowl and fisheries. It is a Section 10 waterway and any work in it, or its adjacent wetlands, requires a USACE permit .
