C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Based on the October 1, 2014 site inspection, no waters of the U.S. are present above the OHWM of the Maumee River at the location of the proposed Hoff Ct. and N. West Street sewer improvement project. According

to the December 1979 Navigability Study of the Maumee River, Indiana, the documented OHWM of the Maumee River near this location is 730.47' (USGS 1929 Datum) at the Landin Street Bridge which is approximately 0.5 river miles downstream of the review area . Plant species observed in the upland at this location include *Phytolacca americana* (FACU), *Oenothera biennis* (FACU), *Fallopia scandens* (FAC), *Oxalis stricta* (FACU), *Juglans nigra* (FACU), and *Lonicera* sp.
