located northwest of the intersection of S.R. 16 and C.R. 180. I also viewed the site from the C.R. 180, S.R. 16, and the neighboring property on July 9, 2015. The web soil survey depicts hydric soils within a portion of the parcel in question. Google Earth aerial photos depict wet signatures within the property in question in 1998, 2003, 2004, 2005, 2006, 2007, 2008, 2010, and 2013 as expressed by dark soils, and/or stunted/discolored vegetation. In all of those aerial photos there is evidence of row crop production. The complainant informed me that the parcel had been planted to corn or soybeans in the years leading up to the construction of the large pond and resulting berm. There was widespread local flooding at the time of inspection. Several inches of standing water was present on the complainant's property, in the areas around the berms, and in roadside swales along S.R. 16 and C.R. 108. The roadside swales, though inundated did not support a dominance of hydric vegetation, and based upon aerial photography, the parcel in question did not either. I did not observe a dominance of wetland vegetation around or near any of the bermed areas I could view from the roadside or neighboring parcel. Therefore, it is unlikely that the parcel in question would have met wetland criteria prior to pond and berm construction. It appears that the large pond and resulting berms were constructed in a non-wetland agricultural field.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Based upon aerial photography and information received at the July 9, 2015 inspection, the parcel in question had been planted to corn or soybeans for agricultural row crop production for several years prior to

construction of the pond and resulting berm. The site did not appear to support a dominance of hydrophytic vegetation prior to construction and therefore would have not likely met wetland criteria. The parcel in question does not contain a jurisdictional water of the U.S; the pond was constructed in a non-wetland agricultural field.
