regulated under a nexus to interstate/foreign commerce based solely on the “Migratory Bird Rule” (MBR). The wetland lacks nexus to interstate/foreign commerce per the criteria in Section III. A-E of the Approved JD form, which uses 33 CFR 328.3 for the definition of waters of the U.S. This is based on the following: Review of the applicable USGS Topo maps, aerial photography, and county drainage maps do not indicate the presence of hydrologic surface or subsurface connection to downstream waters (i.e., the water(s) is/are not part of a tributary system to a TNW). Also, per the site inspection completed on 10/29/15, there was no observed surface water or subsurface water connection (tile) noted between the subject wetland and waters of the United States. Also, during the walk-through of the site, it was determined that the wetland was situated in a depressional setting with no established nexus to a Traditional Navigable water of the United States.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

The wetland identified on the attached map has been determined to be an isolated/non-jurisdictional wetland under the CWA and, prior to the Jan 2001 Supreme Court decision in "SWANCC," the review area would have been regulated under a nexus to interstate/foreign commerce based solely on the "Migratory Bird Rule" (MBR). The wetland lacks nexus to interstate/foreign commerce per the criteria in Section III. A-E of the Approved JD form, which uses 33 CFR 328.3 for the definition of waters of the U.S. This is based on the following: Review of the applicable USGS Topo maps, aerial photography, and county drainage maps do not indicate the presence of hydrologic surface or subsurface connection to downstream waters (i.e., the water(s) is/are not part of a tributary system to a TNW). Also, per the site inspection completed on 10/29/15, there was no observed surface water or subsurface water connection (tile) noted between the subject wetland and waters of the United States. Also, during the walk-through of the site, it was determined that the wetland was situated in a depressional setting with no established nexus to a Traditional Navigable water of the United States.
