(map showing 2012-2013 property boundary attached); it was determined by the Corps that all aquatic resources within the boundary of the 2013 AJD area were isolated waters. It should be noted that the subject property has undergone preliminary ground disturbance by multiple land owners over several years prior to abandonment of plans for development of the site. We were recently notified and informed that a new owner and engineering construction company are now developing the site for a gas-fired energy generation facility; aspects of the previous 2013 designed project as well as the acreage of the project area have been modified (new site plan attached). As a result of this, wetland areas outside of the 2013 AJD area have been identified and have been or will be impacted. Subsequently, two new review areas have been identified: (1) Proposed Northern Laydown area and (2) Outfall Farm Field area (map attached). A site meeting with the consultant was conducted on February 4, 2016. Delineations for the two newly identified areas were submitted on February 16, 2016. Boundaries for wetlands identified within the Northern Laydown area were evident during the February inspection. However, because the delineation was performed outside of the growing season, the consultant performed a second delineation at the Outfall Farm Field and submitted a revised report on April 11, 2016. Wetlands within the Proposed Northern Laydown area consist of (a) a linear wetland swale (0.22 acres) located along the southern side of an access drive (labeled "ditch" on the consultant's graphic) and (b) shallow, historic "borrow pits" (western area 3.32 acres and eastern area 0.35 acres = 3.67 acres), which extend north beyond the review area. This area was excavated prior to 2003 in hydric soils (Rensselaer loam, 0 to 1% slopes) and meets all three wetland criteria per the 1987 Delineation Manual and the Midwest Regional Supplement. The "borrow pits" were inundated at the time of the inspection, however, aerial photos indicate the presence of emergent and scrub-shrub vegetation. The consultant's report indicates that this area had been previously mowed. The wetland areas identified within the "Proposed Northern Laydown" area have been determined to be isolated/non-jurisdictional wetlands under the CWA and, prior to the January 2001 Supreme Court decision in "SWANCC", the review area would have been regulated under a nexus to interstate/foreign commerce per the factors in Section III.F of the Approved JD Form and per factors in 40 CFR 328.3(a)(3)(c&d). This is based on the following: Review of applicable USGS topographic maps, aerial photography, and county drainage maps do not indicate the presence of hydraulic surface or subsurface connection to downstream waters and are, therefore, not part of a tributary system to the Kankakee River (TNW). In addition, per the site inspection conducted on February 4, 2016, no physical connection was observed between the subject wetlands located in the area labeled "Proposed Northern Laydown" and an RPW and/or a NON-RPW and ultimately a TNW.

Summarize overall biological, chemical and physical functions being performed: The wetlands within the review area (Outfall Farm Field) are located within a previously farmed agricultural field and are adjacent to an RPW. The dominant vegetation is moneywort (FACW), with approximately 50% coverage, with the remaining area being bare ground. Hydric soils and hydrologic indicators are present. The consultant's report refers to the 2012 delineation report (map of 2012 review area attached), noting that the three wetlands currently observed are generally consistent and similar to site hydrology, soils and vegetation that were observed in similar wetlands delineated during the 2012 growing season within the adjacent 2012 review area. The wetlands in question were likely at one time to have been connected to a large wetland complex that has been diminished in size due to historic fill from surrounding industrial development. Niespodziany Ditch is a legal regulated county drain and is on the state's 303(d) list of impaired waters. The wetlands serve to buffer agricultural and industrial runoff that would otherwise immediately drain into the Niespodziany Ditch and eventually the Kankakee River, a navigable water of the U.S..

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
