C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The Noyer Open Drain is considered by Allen County to be regulated drain subject to periodic maintenance. Subsequently, the drain is an important drainage mechanism for surrounding agricultural fields and low density residential developments (860 total acres of drainage area with approximately 700 acres in crop rotation according to the Purdue University L-THIA watershed delineator tool).

B. ADDITIONAL COMMENTS TO SUPPORT JD: A site visit was completed with the consultant on 4/20/16 to review the delineation report for accuracy. Areas of hydric soil were noted on the soil survey (Pe Pewamo), however, the inspection revealed that the hydric soil units were in active crop rotation and did not have a dominance of hydrophytic vegetation (wetland criteria not met).
