surface drainage or other potential connection to downstream waters were observed during the site inspections or noted in the consultant's report. No subsurface drainages (tiles) are visible on applicable county maps. This isolated wetland is situated in a depression with no known hydrologic connection to a downstream water.

Wetland Section II is a 0.22 acre isolated forested wetland. This wetland is within depression that forms a swale-like feature. A standpipe was noted at the east end of the wetland, however its function is unknown. No surface water or flow was observed upon multiple inspections. This pipe or any potential subsurface pipes or tiles are not visible on applicable county drainage or utility maps. According to the consultant, the recent survey of the property did not reveal any information regarding the possible function or location of any potential subsurface drainages (pipes or tiles). Therefore, there is no known subsurface hydrologic connection to a downstream water. Aerial photos show potential wet signatures which could possibly indicate overland flow, however the inspections revealed these areas to be upland with no indicators of hydrology. The entire wetland is surrounded by upland. This isolated wetland is situated in a depression with no known hydrologic connection to a downstream water.

Wetland Section III is a 0.84 acre isolated forested wetland. The entire wetland is surrounded by upland. No surface drainage or other potential connection to downstream waters were observed during the site inspections or noted in the consultant's report. No subsurface drainages (tiles) are visible on applicable county maps. This isolated wetland is situated in a depression with no known hydrologic connection to a downstream water.

Wetland Section IV is a 0.19 acre isolated forested wetland. The entire wetland is surrounded by upland. No surface drainage or other potential connection to downstream waters were observed during the site inspections or noted in the consultant's report. No subsurface drainages (tiles) are visible on applicable county maps. Aerial photos show potential wet signatures possibly indicating overland flow, however the inspections revealed these areas to be upland with no indicators of hydrology. This isolated wetland is situated in a depression with no known hydrologic connection to a downstream water.

Wetland Section V is a 0.24 acre isolated forested wetland. This wetland is within a depression that forms a swale. Aerial photos show potential wet signatures possibly indicating overland flow, however the inspections revealed these areas to be upland with no indicators of hydrology. The entire wetland is surrounded by upland. No subsurface drainages (tiles) are visible on applicable county maps. This isolated wetland is situated in a depression with no known hydrologic connection to a downstream water.

Wetland Section VI is a 0.37 acre isolated forested wetland. The entire wetland is surrounded by upland. No surface drainage or other potential connection to downstream waters were observed during the site inspections or noted in the consultant's report. No subsurface drainages (tiles) are visible on applicable county maps. This isolated wetland is situated in a depression with no known hydrologic connection to a downstream water.

Wetland Section VII is a 0.09 acre forested wetland. The wetland appears to form a swale with a potential drainage to a standpipe southwest of the wetland. The function of this standpipe is unknown. No surface water or flow was observed upon multiple inspections. This pipe or any potential subsurface pipes or tiles are not visible on applicable county drainage or utility maps. According to the consultant, the recent survey of the property did not reveal any information regarding the possible function or location of any potential subsurface drainages (pipes or tiles). Therefore, there is no known subsurface hydrologic connection to a downstream water. Aerial photos show potential wet signatures to the east of the wetland possibly indicating overland flow, however the inspections revealed these areas to be upland with no indicators of hydrology. Additional review of maps do not indicate potential surface connections to downstream waters, either on or off-site. The consultant delineated the property to the north and did not record wetlands or other waters in the vicinity of Section VII. This isolated wetland has no known hydrologic connection to a downstream water..

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

No subsurface drainages (tiles) are visible on applicable county maps. This isolated wetland is situated in a depression with no known hydrologic connection to a downstream water.

Wetland Section VII is a 0.09 acre forested wetland. The wetland appears to form a swale with a potential drainage to a standpipe southwest of the wetland. The function of this standpipe is unknown. No surface water or flow was observed upon multiple inspections. This pipe or any potential subsurface pipes or tiles are not visible on applicable county drainage or utility maps. According to the consultant, the recent survey of the property did not reveal any information regarding the possible function or location of any potential subsurface drainages (pipes or tiles). Therefore, there is no known subsurface hydrologic connection to a downstream water. Aerial photos show potential wet signatures to the east of the wetland possibly indicating overland flow, however the inspections revealed these areas to be upland with no indicators of hydrology. Additional review of maps do not indicate potential surface connections to downstream waters, either on or off-site. The consultant delineated the property to the north and did not record wetlands or other waters in the vicinity of Section VII. This isolated wetland has no known hydrologic connection to a downstream water.

Therefore, wetlands Section I, Section II, Section III, Section IV, Section V, Section VI, and Section VII are isolated wetlands and are not considered waters of the United States. Willow Creek Branch #7 and McComb Drain are relatively permanent waters that are part of the tributary system of the Maumee River and therefore are waters of the United States.
