Summarize overall biological, chemical and physical functions being performed: Wetland Section I, II, III and IV provide a buffer to the existing landscape, which is dominated by an agricultural setting with burgeoning high density/low density residential and commercial development on the fringes of the area. Based upon the current and potential development conditions, the above mentioned wetland provides more than an insubstantial or insignificant benefit as a buffer to the downstream water quality in the Little River watershed (TNW). The Little River drainage suffers from flooding issues on a regular basis compounded by loss of buffer from development and increased agricultural runoff from over-taxed tiles and ditches.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

Section IV gains an OHWM and defined bed and bank near the southeast corner of the project area and becomes an ephemeral tributary which flows to Flaugh Ditch. Flaugh Ditch flows to the Graham McCulloch Ditch a tributary of the Little River, which is a TNW. The subject tributary appears to flow primarily during precipitation events and snow melt as evident by the lack of flow noted during the second site inspection. During rain events, the subject wetlands attenuate surface water and contribute flow to the above mentioned ephemeral stream. Ephemeral streams of this type contribute potential flood waters, sediments, and nutrients to downstream waters which eventually reach a TNW such as the Little River. The Little River has been the subject of frequent flooding due to increased agricultural and urban drainage in combination with loss of natural buffers such as wetlands. In addition to flooding problems the Little River, which receives water from the subject site, tributaries and wetlands is also listed on the state's 303d list for impaired biotic communities. Based upon the current and potential development conditions, wetland Sections I, II, III and IV in combination with the ephemeral stream, provide more than an insubstantial or insignificant benefit as a buffer to downstream water quality and habitat for terrestrial and aquatic life in rapidly developing watershed within the Fort Wayne area (ref. Purdue University Online Watershed Delineator Tool, LITHA).
