### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Waters/wetlands identified on the attached maps have been determined to be isolated/non-jurisdictional wetlands under the CWA and, prior to the Jan 2001 Supreme Court decision in "SWANCC," the review area(s) would have been regulated under a nexus to interstate/foreign commerce based solely on the "Migratory Bird Rule" (MBR). Waters/wetlands lacked nexus to interstate/foreign commerce per the factors in Section III.F of the Approved JD form and per factors in 40



CFR 328.3(a)(3)(c & d). This is based on the following: Review of the applicable USGS Topo maps, aerial photography, and county drainage maps do not indicate the presence of hydrologic surface or subsurface connection to downstream waters (i.e., the water(s) is/are not part of a tributary system to a TNW). During the site visit conducted on July 21, 2016 no continuous physical connection was observed between subject water(s) and a RPW and/or a Non-RPW and ultimately a TNW. The relatively flat topography surrounding the wetland and lack of soils with similar drainage properties indicate that the wetland receives water from runoff/precipitation events and losses water via evaporation and groundwater recharge and has little effect on the contribution of flow to Clear Lake which eventually discharges into the St. Joseph River, then the Maumee River, a Section 10 Water. Additionally, the surrounding topography and lack of direct and indirect hydrologic connection visa surface or subsurface means indicate that the wetland would have minimal effect on the retention of chemical and other pollutants to downstream waters..
