jurisdictional under the CWA and prior to the Jan 2001 Supreme Court decision in “SWANCC,” the review area would have been regulated under a nexus to interstate/foreign commerce based solely on the “Migratory Bird Rule” (MBR). The wetland/impoundment lacks a nexus to interstate/foreign commerce per the criteria in Section III, A-E of the Approved JD form, which uses 33 CFR 328.3 for the definition of waters of the United States. This is based on the following: Review of the applicable USGS Topo maps, aerial photography and county drainage maps do not indicate the presence of hydrologic surface or subsurface connections to downstream waters (i.e., the waters are not part of a tributary system to a Traditional Navigable Water of the United States [TNW]). Also, per the site inspection completed on September 16, 2016 there was no observed surface water or subsurface water connection (drainage tile) noted between the subject wetlands and waters of the United States. Further, the spillway/overflow for the impoundment flows into forested wetlands. Surface water from the forested wetlands does not reach the box culvert under SR 9 which is located at the the lowest elevation of the parcel (The forested wetlands below the spillway are positioned at a higher elevation with no nexus noted between the wetlands and box culvert). Therefore, the subject wetland/impoundment was determined to have no established nexus to a TNW.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
