C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: A site inspection was completed on 11/3/16 to review the area for potential wetlands/waters of the United States. The area for the proposed home addition and stand-alone garage was noted to be an upland lawn that did not meet wetland criteria. The property does abut Golden Lake (approximately 90 feet of frontage), however the proposed construction

work for the home addition will start approximately 30 feet landward of the OHWM of the lake in an upland area on the west side of the existing dwelling. The work for the proposed garage will occur approximately 80 feet landward of the OHWM of Golden Lake.
