to the JAN 2001 Supreme Court decision in "SWANCC", Wetlands 1 and 2 would have been regulated under a nexus to interstate/foreign commerce based solely on the "Migratory Bird Rule" (MBR). The wetlands lacked nexus to interstate/foreign commerce per the factors in Section III.F of the Approved JD form and per factors in 40 CFR 328.3(a)(3)(c & d). This is based on the following: Review of the applicable USGS Topo maps, aerial photography, and county GIS (MACOG) maps do not indicate the presence of hydrologic surface or subsurface connection to downstream waters; during site visits on December 6, 2016 and May 9, 2017 no continuous physical connection was observed between the subject wetlands and a RPW and/or Non-RPW and ultimately a TNW; and the subject wetlands were determined to not be adjacent to other waters of the U.S. under Corps' regulatory jurisdiction. Wetland 1 is identified as a depressional area on the USGS topographic map (1:24K; IN-ELKHART). During the site visits, no continuous surface or subsurface connection to a waters of the U.S. from Wetlands 1 and 2 was observed in the field.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetlands 1 and 2 were determined by the District to be isolated (as defined in 33 CFR 330.2(e)) and not adjacent as defined in 33 CFR 328.3(c). Therefore, these wetlands are not a water of the U.S. subject to jurisdiction under Section 404 of the Clean Water Act.
