B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). Explain: Although the tributary was dry at the time of our site inspection, based upon the report provided by the agent, the consultant indicated they "observed riffles, runs, and pools" during their survey and noted that "pools reached a depth greater than 24 inches in several locations".

Describe flow regime: The flow of the Unnamed Tributary to Eller Ditch is predominantly driven by seasonal events such as snowmelt and responds to precipitation events throughout the year. Based upon aerial imagery taken in the early spring of 2005, the tributary appears to be flowing at full capacity. In addition to aerial imagery, the report provided by the agent included photographs taken on May 25, 2017 that showed water flowing through the tributary. The Unnamed Tributary to Eller Ditch running through the parcel is mapped on the United States Geological Survey's National Hydrography Dataset (NHD) as an intermittent stream and is defined as having "water most of the year". Additionally, the Unnamed Tributary to Eller Ditch is mapped as a stream feature on the NRCS's Web Soil Survey for St. Joseph County.

(iii) Chemical Characteristics:

Explain: At the time of the site inspection, the Unnamed Tributary to Eller Ditch was dry and no water was being conveyed through the parcel, so no characterization could be made of the water color or quality. The Unnamed Tributary to Eller Ditch drains a mixed use area including residential, agricultural, and forested land. Due to the tributary's proximity to agricultural areas, one would expect to find increased levels of Nitrogen and Phosphorous from fertilizer as well as toxins from herbicides and pesticides. Sediment loads would also be expected to be high following precipitation events during crop off periods of the year due to surface runoff from the agricultural land to the east. Additionally, the parcel is abutted to the south by US-20 (St. Joseph Valley Parkway) and we would expect to find pollutants within the unnamed tributary associated with runoff from roads.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The Unnamed Tributary to Eller Ditch is a seasonal RPW that exhibits an Ordinary High Water Mark (OHWM) and a defined bed and bank. The RPW is depicted by a dotted blue line (intermittent stream) on the United States Geological Survey's Topographic map (1:24,000, IN-South Bend East). The Unnamed Tributary to Eller Ditch is a tributary to Eller Ditch, an RPW, and flows directly into the St. Joseph River (TNW). Therefore, the Unnamed Tributary to Eller Ditch is an RPW within the tributary system of the St. Joseph River and should be considered a water of the United States.
