prior to the JAN 2001 Supreme Court decision in "SWANCC", the identified wetland would have been regulated under a nexus to interstate/foreign commerce based solely on the "Migratory Bird Rule" (MBR). The wetland lacked nexus to interstate/foreign commerce per the factors in Section III.F of the Approved JD form and per factors in 40 CFR 328.3(a)(3)(c & d). This is based on the following: during a site visit on November 10, 2016 no continuous physical connection was observed between the subject wetland and a RPW and/or Non-RPW and ultimately a TNW; and the subject wetland was determined to not be adjacent to other waters of the U.S. under Corps' regulatory jurisdiction. This wetland is identified as a depression area on the USGS topographic map (1:24K; IN-LORANE). During our site visit, no surface or subsurface connection to a waters of the U.S. was observed in the field.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
