The area in question (potential jurisdictional wetland) is a stormwater detention/retention basin that appears to have been excavated in dry land in 1998 (based on a 1998 aerial photograph). Wetland signatures were not identified in the area of the stormwater basin on reviewed historical aerial photographs (years 1952, 1960, 1973, 1979, 1983, 1987, and 1994). The mapped soils in the area of the stormwater detention basin are Hoytville silty clay (HTa), a partially hydric soil, and Nappanee silt loam (Na), a non-hydric soil. The NWI identifies the stormwater detention/retention basin as PEMC1 (Palustrine, Emergent, Seasonally Flooded Wetland). According to 33 CFR Part 328, areas excavated for water treatment are not jurisdictional waters of the U.S. Therefore, the stormwater detention/retention basin is not a jurisdictional waters of the U.S.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
