C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The wetland swale areas have resulted from the rock quarry operations. The rock quarry is on-going on the property, but according to the consultant will be abandoned for the proposed development within this area. Per 33 CFR 328.3(e) waterfilled depressions created in upland incidental to construction are not Waters of the U.S. unless they have naturalized and been abandoned and meet the definition of a Water of the U.S. found at 33 CFR 328. 3(a). The wetland and open water areas shown are

isolated, non-navigable, intrastate waterways with no "significant nexus" to waters of the United States or commerce. The wetland and open water pit are set in depression area created as a result of gravel mining and do not exhibit any hydrologic connection or adjacency to any stream or other "waters of the United States" and is not susceptible to use in interstate or foreign commerce. The wetland is 0.32 acres in size and the open water pit area located within this property is 1.71 acres. The waterways as identified on the attached maps has been determined to be isolated/non-jurisdictional wetlands under the CWA and, prior to the Jan 2001 Supreme Court decision in "SWANCC," the review area(s) would have been regulated under a nexus to interstate/foreign commerce based solely on the "Migratory Bird Rule" (MBR). Waters/wetlands lacked nexus to interstate/foreign commerce per the factors in Section III.F of the Approved JD form and per factors in 40 CFR 328.3(a)(3)(c & d). This is based on the following: Review of the applicable USGS Topo maps, aerial photography, and county drainage maps do not indicate the presence of hydrologic surface or subsurface connection to downstream waters (i.e., the water(s) is/are not part of a tributary system to a TNW). During the site visit conducted on May 9, 2017 no continuous physical connection was observed between subject water(s) and a RPW and/or a Non-RPW and ultimately a TNW. Subject wetlands were determined to not be adjacent to other waters of the United States under Corps' regulatory jurisdiction. Review of the Soil Survey suggests the subject waterways developed as a result of gravel mining. Aerial imagery of the project site show no dark signatures indicating overland flow. No overland flow or evidence of overland flow were observed. We found the wetland/waterway located in a landscape position that precludes a hydrologic connection to waters that are part of a tributary system.
