REVIEW AREA ONLY INCLUDES DRY LAND: The review area, an approximate 100 foot by 100 foot area, extends southeast from an existing house, across a gravel driveway and approximately 10 feet into a low lying swale dominated by Eastern White Pine (*Pinus strobus*, FACU). The entire review area is non-wetland (upland).
