isolated/non-jurisdictional waters/wetlands under the CWA and, prior to the JAN 2001 Supreme Court decision in "SWANCC", the review area would have been regulated under a nexus to interstate/foreign commerce based solely on the "Migratory Bird Rule" (MBR). The identified wetland and waterways lacked nexus to interstate/foreign commerce per the factors in Section III.F of the Approved JD form and per factors in 40 CFR 328.3(a)(3)(c & d). This is based on the following: Review of the applicable USGS Topo maps, aerial photography, soil map, and county GIS (MACOG - Elkhart) maps do not indicate the presence of hydrologic surface or subsurface connection to downstream waters; during a site visit on September 13, 2017 no continuous physical connection was observed between the subject wetland and waters and a RPW and/or Non-RPW and ultimately a TNW; and the subject wetland was determined to not be adjacent to other waters of the U.S. under Corps' regulatory jurisdiction. During the site visit, no continuous surface or subsurface connection to a waters of the U.S. from Wetland 1 and Streams 1, 2 and 3 were observed in the field. Wetland 1 is located in a depressional area and formed in non-hyric soils. Wetland 1 receives stormwater runoff from Streams 1, 2, and 3 and upland portions of the site. Stream 1, 2, and 3, which drain into Wetland 1, are located in non-hyric soils and appear to have formed from storm water drainage from State Road 19 and the existing residential subdivision to the south. .

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

B. ADDITIONAL COMMENTS TO SUPPORT JD: The identified wetland (Wetland 1) and waterways (Streams 1, 2, and 3) were determined by the District to be isolated (as defined in 33 CFR 330.2(e)) and not adjacent as defined in 33 CFR 328.3(c). Therefore, the identified wetland and waterways are not a water of the U.S. subject to jurisdiction under Section 404 of the Clean Water Act.
