Summarize overall biological, chemical and physical functions being performed: Wetlands on site retained and desynchronized flows of water into Beeching F and Solon M#3 Drains. Likewise wetlands filtered run-off from adjacent roadways, which contains oil, greases, salts, and other typical urban/suburban run-off pollutants.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Smaller tiles such as these often provide direct water inputs into perennial tributaries including storm water and snow melt water with substantial amounts of sediment and agricultural chemicals. Wetlands adjacent to small drains can store runoff water and reduce flood peaks downstream while removing pollutants before they enter drains and ditches. Most of the wetlands in the Eel River watershed in Indiana are relatively small and have been impacted for development or agricultural purposes. The drainage work facilitated the pervasive conversion of the landscape to agricultural land. Prior to drainage efforts, the Eel River's watershed was basically large forested wetland with interspersed marshes and uplands. The ditches that drain the area are conduits for fast drainage and provide little flood retention and little ability to filter/retain pollutants. Most of the streams and ditches in the watershed have been channelized, deepened, straightened, and/or dredged at some time over the last 150 years to support agriculture and construction of roads and cities. The remaining wetlands in the watershed, including the subject wetlands, play a significant role in mitigating effects on the biological, chemical, and physical integrity of the Eel River and the downstream waters of the Wabash. Limiting pollutants of any type in the upstream reaches of the Eel River and Wabash River watershed assists in the lower of pollutant levels downstream. The subject wetlands do store and slowly release potential flood waters to the Eel and Wabash Rivers. .
