### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The open water areas shown is an isolated, non-navigable, intrastate waterways with no "significant nexus" to waters of the United States or commerce. The open water is set in depression area created and do not exhibit any hydrologic connection or adjacency to any stream or other "waters of the United States" and is not susceptible to use in interstate or foreign commerce. The open water pond area located within this property is 0.2 acres. The waterways as identified on the attached maps has been

determined to be isolated/non-jurisdictional wetlands under the CWA and, prior to the Jan 2001 Supreme Court decision in "SWANCC," the review area(s) would have been regulated under a nexus to interstate/foreign commerce based solely on the "Migratory Bird Rule" (MBR). Waters/wetlands lacked nexus to interstate/foreign commerce per the factors in Section III.F of the Approved JD form and per factors in 40 CFR 328.3(a)(3)(c & d). This is based on the following: Review of the applicable USGS Topo maps, aerial photography, and county drainage maps do not indicate the presence of hydrologic surface or subsurface connection to downstream waters (i.e., the water(s) is/are not part of a tributary system to a TNW). During the site visit conducted on July 11, 2017 no continuous physical connection was observed between subject water(s) and a RPW and/or a Non-RPW and ultimately a TNW. Subject waterways were determined to not be adjacent to other waters of the United States under Corps' regulatory jurisdiction. Aerial imagery of the project site show no dark signatures indicating overland flow. No overland flow or evidence of overland flow were observed. We found the waterway located in a landscape position that precludes a hydrologic connection to waters that are part of a tributary system.
