exhibit an Ordinary High Water Mark (OHWM) or indicators of an OHWM as defined in Regulatory Guidance Letter (RGL) No. 05-05. Further, it was noted during our September 13, 2017 site inspection that these linear features were dominated by *Trifolium pratense* (Clover), *Taraxacum officinale* (Dandelion), and *Daucus carota* (Queen Anne's Lace) and would not meet wetland criteria as described in the 1987 Corps of Engineers Wetland Delineation Manual. Wetland B is situated in a small depression within a highly disturbed upland landscape. Additionally, based upon our site inspection, review of the applicable USGS Topographic maps, aerial photography, and county drainage maps, there does not appear to be the presence of a hydrologic surface or subsurface connection between Wetland B and downstream Waters of the United States. During our site inspection, no potential flow path or other potential surface or subsurface hydrologic connection to a Water of the United States was observed. The on-site Pond was excavated entirely out of upland during the previous expansion of the substation site for the purpose of collecting, settling, and retaining stormwater and is not to be considered a Water of the United States per 33 CFR 328.3.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Further, it was noted during our September 13, 2017 site inspection that these linear features were dominated by *Trifolium pratense* (Clover), *Taraxacum officinale* (Dandelion), and *Daucus carota* (Queen Anne's Lace) and would not meet wetland criteria as described in the 1987 Corps of Engineers Wetland Delineation Manual. Wetland B has no observable hydrologic connection to a Water of the United States and is an isolated depression situated wholly within a highly disturbed upland landscape. No potential flow path or other potential surface or subsurface hydrologic connection to a Water of the United States was observed. Therefore, Wetland B is located in a landscape position that precludes a hydrologic connection to waters that are part of the tributary system of the Maumee River and should not be considered a Water of the United States. Additionally, the on-site Pond was excavated entirely out of upland during the previous expansion of the substation site for the purpose of collecting, settling, and retaining stormwater (stormwater treatment system) and is not to be considered a Water of the United States per 33 CFR 328.3.
