subsurface hydrologic connection to a downstream TNW. At the October 12, 2017 site inspection, I observed a tile drain pipe flowing into Wetland Section I. Surface run-off from the adjacent bean-field was also flowing into Wetland Section I. A natural surface drainage was flowing from Wetland Section I connecting to Wetland Section II. I observed a drain pipe that appeared to outlet into Wetland Section II, however, I did not locate a potential outlet from Wetland Section II. Water appears to pool regularly in Wetland Section II. At Wetland Section III, I observed a standpipe at the forest edge. According to the consultant, the property owner has stated that all tiles on the property drain into the forested area. The delineated wetlands are depressions in the landscape, and aside from the drainage connecting Wetland Section I and Wetland Section II, those depressions are surrounded by upland forest or farm field. The entire forested parcel is surrounded by farm field that was planted to soybeans at the time of inspection. Because of the lack of a surface or known subsurface hydrologic connection to a downstream water, Wetlands Section I, Section II, and Section III appear to be isolated. Isolated/non-jurisdictional waters/wetlands prior to the January 2001 Supreme Court decision in "SWANCC" would have been regulated under a nexus to interstate/foreign commerce based solely on the "Migratory Bird Rule" (MBR). Therefore, Wetland Section I, Wetland Section II, and Wetland Section III appear isolated from a TNW and are not considered waters of the United States. .

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Wetlands Section I, Section II, and Section III are isolated forested wetlands with no known surface or subsurface hydrologic connection to a downstream TNW. At the October 12, 2017 site inspection, I observed a tile drain pipe flowing into Wetland Section I. Surface run-off from the adjacent bean-field was also flowing into Wetland Section I. A natural surface

drainage was flowing from Wetland Section I connecting to Wetland Section II. I observed a drain pipe that appeared to outlet into Wetland Section II, however, I did not locate a potential outlet from Wetland Section II. Water appears to pool regularly in Wetland Section II. At Wetland Section III, I observed a standpipe at the forest edge. According to the consultant, the property owner has stated that all tiles on the property drain into the forested area. The delineated wetlands are depressions in the landscape, and aside from the drainage connecting Wetland Section I and Wetland Section II, those depressions are surrounded by upland forest or farm field. The entire forested parcel is surrounded by farm field that was planted to soybeans at the time of inspection. Because of the lack of a surface or known subsurface hydrologic connection to a downstream water, Wetlands Section I, Section II, and Section III appear to be isolated. Isolated/non-jurisdictional waters/wetlands prior to the January 2001 Supreme Court decision in "SWANCC" would have been regulated under a nexus to interstate/foreign commerce based solely on the "Migratory Bird Rule" (MBR). Therefore, Wetland Section I, Wetland Section II, and Wetland Section III appear isolated from a TNW and are not considered waters of the United States.
