C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetlands identified as Section I and Section II on the attached maps have been determined to be isolated/non-jurisdictional wetlands under the CWA and, prior to the Jan 2001 Supreme Court decision in "SWANCC," the review area(s) would have been regulated under a nexus to interstate/foreign commerce based solely on the "Migratory Bird Rule" (MBR). Waters/wetlands lacked nexus to interstate/foreign commerce per the factors in Section III.F of the Approved JD form and per factors in 40 CFR 328.3(a)(3)(c & d). This is based on the following: Review of the applicable USGS Topo maps, aerial photography, and county drainage maps do not indicate the presence of hydrological surface or subsurface connection to downstream waters (i.e., the water(s) is/are not part of a tributary system to a TNW). During the site visit conducted on September 12, 2017 no continuous physical connection was observed between subject water(s) and a RPW and/or a Non-RPW and ultimately a TNW. While a connection is shown on the NHD Streams and Ditches National Hydrography Dataset it does not exist in the field. Subject wetlands were determined to not be adjacent to other waters of the United States under Corps' regulatory jurisdiction. Because these areas were determined to be isolated and non-jurisdictional the exact wetland boundaries were not agreed during the site inspection. Review of the Soil Survey suggests the subject waters developed in glacially formed depressions (i.e., pothole or kettle wetlands). Aerial imagery of the project did not site show any dark signatures possibly indicating overland flow. These areas were also investigated during the site inspection on September 12, 2017 to determine if overland sheet flow to other waterbodies occurs. No overland flow or evidence of overland flow was observed. The area between this wetland and other wetland/waterways is of a higher elevation. The isolated wetlands do not affect the physical, chemical, or biological integrity of a downstream TNW due to the lack of a continuous hydrological connection via surface, subsurface, and overland flow, and the lack of continuous physical connection. .
