did not observe any surface or subsurface hydrologic connection from this wetland to a potential TNW or its tributaries. I investigated a pipe that appears to outlet into the wetland from the farm-field to the south. The pipe and farm field sit higher in the landscape than the wetland. I did not locate a potential outlet from the wetland; it is surrounded entirely by upland. A rise in topography separates the wetland from the RPW at the north end of the property. Because of the lack of a hydrologic connection to a downstream water, this wetland appears to be isolated. Isolated/non-jurisdictional waters/wetlands prior to the January 2001 Supreme Court decision in "SWANCC" would have been regulated under a nexus to interstate/foreign commerce based solely on the "Migratory Bird Rule" (MBR). Therefore, wetland Section I appears isolated from a TNW and is not considered a water of the United States..

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The feature labeled Section II on the attached figure is Beedy Ditch, also known as the Paul Freeman Legal Drain. This RPW becomes the Alex Warner Ditch and flows into the St. Joseph River. The St. Joseph River is a tributary of the Maumee River, a TNW. Therefore, Section II is considered a water of the United States.
