middle of the parcel. It was also noted that approximately half of the parcel contained the hydric soil Pewamo silty clay loam, according to the NRCS's Web Soil Survey for Allen County. During our December 07, 2017 site inspection, we observed the vegetation within the wetland area was mostly Eastern Cottonwood (*Populus deltoids*). We observed a small area in the center of the wetland that contained Reed Canary Grass (*Phalaris arundinacea*) and Smartweed (*Polygonum* sp.). The vegetation observed in upland areas surrounding the wetland on the parcel included Cut-Leaf Teasel (*Dipsacus laciniatus*), Queen Anne's Lace (*Daucus carota*), and Kentucky Blue Grass (*Poa pratensis*). Hydrology for the wetland is driven by precipitation in the form of rainfall, snowmelt, and runoff from surrounding properties and Leesburg Road to the north. Based upon our site inspection, review of the applicable USGS Topographic maps, aerial imagery, and county drainage maps, there does not appear to be the presence of a hydrologic surface or subsurface connection between the wetland and downstream Waters of the United States. The elevation contours suggest that the wetland area is in a small depression within the surrounding upland landscape and Leesburg Road to the north. The USGS Topographic map did not indicate the presence of surface water (RPW, Non-RPW, or TNW) in the vicinity of the wetland. As a result, we did not observe a berm or other man-made structure separating the wetland from a surface water. The iMap Allen County GIS Engineering Viewer identified a county regulated drain running from the property north of Leesburg Road, through (under) the Graves property, and continuing to the south (John Rapp Br. 2). Although two stand pipes associated with the subsurface tile were observed on the property, no potential flow path or other potential surface or subsurface hydrologic connection to them from the wetland was observed. The depressional wetland does not provide for interstate or foreign commerce, is not subject to commercial use currently, and will not be subject to commercial use in the future. In addition, we observed no evidence that suggests the wetland supports recreational use and there are no known species that require the wetland to fulfill their life cycle requirements.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

ADDITIONAL COMMENTS TO SUPPORT JD:** The wetland on the parcel has no observable hydrologic connection to a Water of the United States and is an isolated depression situated wholly within an upland landscape. No potential flow path or other potential surface or subsurface hydrologic connection to a Water of the United States was observed. Therefore, the wetland is located in a landscape position



that precludes a hydrologic connection to waters that are part of the tributary system of the Eel River and should not be considered a Water of the United States.
