### **SECTION III: CWA ANALYSIS**

#### **A. TNWs AND WETLANDS ADJACENT TO TNWs**

##### **2. Wetland adjacent to TNW**

Summarize rationale supporting conclusion that wetland is “adjacent”: Historically, the wetlands located on the Garvey site were contiguous to an extensive wetland known as Verchev’s Marsh. This extensive wetland complex contains mostly emergent and submerged marsh plant communities in the areas lower in elevation and waterward of the OHWM of Lake St. Clair. The forested wetland part of the complex found at the Garvey site is located in the areas immediately adjacent and landward of the OHWM. The Macomb County Soil Survey shows a contiguous soil mapping unit of Lamson fine sandy loam (poorly drained, hydric soil) extending from the currently inundated marsh area of Verchev’s Marsh, through the entire Garvey site and continuing north and west across the contiguous forested wetland area located immediately adjacent to the Garvey site. The attached aerial photograph dated 26 May 1976 shows the physical extent of standing water in Lake St. Clair as extending to a flood control dike built by the Corps of Engineers in 1973-74 under Operation Foresight. The recorded water level of Lake St. Clair on the date the aerial was taken (26 May 1976) was approximately 576.3 feet to 576.4 feet (IGLD 85), or at the approximate OHWM of 576.3 feet (IGLD) for Lake St. Clair. The construction of the Corps Operation Foresight dike and the subsequent discharge of fill material created in a barrier between the between the coastal Lake St. Clair wetlands and the forested wetland system on the site. However, as stated in the Federal Register at 33CFR Part 328.3©, adjacent is defined as "boring, contiguous, or neighboring. Wetlands separated from other waters of the United States by man-made dikes or barriers, natural barriers, natural river berms, beach dunes and the like are "adjacent wetlands". The Operations Foresight dike and nearby Riverside Bayview fill material are "man-made dikes or barriers" and thus the wetlands at the Garvey site are "adjacent wetlands".

#### **B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):**

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). If the waterbody<sup>4</sup> is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**

- Data sheets prepared by the Corps: The Huron Ecologic delineation identified two wetland areas on site that contained all three parameters (soils, hydrology and vegetation). The Huron Ecologic report shows an upland area between the two wetlands. The upland area is identified as being dominated by wetland vegetation and contains hydric soils, but they didn't identify any indicators of hydrology in this area during their November 22, 2015 site inspection. A review of the Huron Ecologic vegetation section of the wetland data form for this area indicates the site met the FAC-Neutral text for hydrology, one of the secondary indicators (though it wasn't checked on their data form). A site inspection on March 29, 2017 by the Corps indicated the upland area between the two wetland identified by Huron Ecologic had standing water or saturated soils across this same area. Since precipitation usually exceeds evaporation during the early growing season in April and May, site is expected to be even wetter than observed during the march 29, 2017 inspection. The vegetation on site, particularly the Phragmites, had been cut and acted as a mulch as it covered much of the ground and was a couple inches deep in some areas. In addition, at least some of the cut trees were stacked on site and/or used to allow vehicle access across the wet soils found on site. A second site inspection on June 28, 2017 indicated an extensive area of the site had evidence of standing water (water stained leaves) and contained water plantain (Alisma plantago-aquatica), an aquatic wetland plant species which this inspector has only seen germinating in shallow standing water or saturated soils.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The Garvey site is located on part of the former Village Building Company (VBC) site (Corps of Engineers File Number 01-010-078-0, also referenced as 2001- 100780). The VBC site was an extensive Detroit District enforcement action after there was unauthorized filling of wetlands on the site in 2001. One of the sampling points from the 2001 site inspection is located on the current Garvey site. This extensive file also made the determination the wetlands back in 2001 that the wetlands on the now Garvey site were adjacent to Lake St. Clair. Owners of the VBC property appealed Corps jurisdiction during the enforcement action; their appeal was determined to not have merit. A copy of this appeal is included in our file. The wetlands on the Garvey site are also within the 100-year floodplain of the Clinton River.
