isolated waters. Wetland 1, as described in the Wetland Delineation Report (Report) provided by Soil Solutions, Inc., is a large open water pond with an emergent wetland fringe approximately 16.21 acres in size. The wetland is located along the western edge of the review area directly east of Boyd Boulevard. The area is mapped as emergent wetland and freshwater pond on the USFWS National Wetland Inventory (NWI) and is primarily mapped as Histosols and Aquolls on the NRCS's Web Soil Survey for LaPorte County. Based upon our site inspection and review of the applicable USGS Topographic maps, aerial imagery, and county drainage maps, there does not appear to be the presence of either a surface or subsurface hydrological connection between the wetland and downstream Waters of the United States. Further, the elevation contours suggest that the wetland area is contained within a landscape depression and Boyd Boulevard to the west. Wetland 1 is not separated by a berm or other man-made structure from a surface water. Wetland 4, as described in the Report, is a small depression wetland 0.04 acres in size surrounded by a wooded area. It appears to be an excavated depression and contains, what appears to be, debris from the construction of a subsurface tile. The small depression is likely a seasonally inundated depression fed by surface water runoff from the surrounding upland area. Review of the applicable USGS Topographic maps, aerial imagery, and county drainage maps did not indicate the presence of a potential flow path or other potential surface or subsurface hydrologic connection to a downstream Water of the United States; this was confirmed during the field inspection. Wetland 4 is not separated by a berm or other man-made structure from a surface water. Neither Wetland 1 or Wetland 4 provide for interstate or foreign commerce, is subject to commercial use currently, or will be subject to commercial use in the future. In addition, there does not appear to be evidence that suggests the either wetland supports recreational use and there are no known species that require the wetlands to fulfill their life cycle requirements.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Satellite imagery, taken from 1998 through 2016, confirms that Schurz Ditch conveys water throughout the year. In addition, low altitude aerial images taken in 2010, 2014 and 2016, sourced from Beacon GIS, provide further evidence that Schurz Ditch conveys water. The United States Fish and Wildlife Survey's National Wetland Inventory (NWI) maps Schurz Ditch as an R2 Lower Perennial stream feature. Note that Schurz Ditch enters a subsurface tile as it flows southeast through the review area. Detroit District File Number LRE-95-146-625-1

provides photographs of Schurz Ditch following the work to contain the open ditch within a subsurface tile. Based upon our site inspection, previous Corps of Engineers documentation, photographs provided by the consultant, and aerial imagery, it is apparent that Schurz Ditch enters the subsurface tile and continues south to its outfall off-site. Schurz Ditch flows approximately 3.15 miles south to its confluence with Travis Ditch (RPW). Travis Ditch flows approximately 8.53 miles south to its confluence with the Kankakee River (TNW).

B. ADDITIONAL COMMENTS TO SUPPORT JD: Schurz Ditch is a perennial RPW that exhibits an Ordinary High Water Mark (OHWM) and a defined bed and bank. The RPW is depicted as a perennial stream on the United States Geological Survey's National Hydrography Dataset (NHD). Schurz Ditch flows approximately 3.15 miles south to its confluence with Travis Ditch (RPW). Travis Ditch flows approximately 8.53 miles south to its confluence with the Kankakee River (TNW). Note that the name of Travis Ditch appears to change to Long Ditch approximately 2.75 miles north of its confluence with the Kankakee River. Based upon our desktop review, no change in stream function or appearance is observed. Therefore, Schurz Ditch is an RPW within the tributary system of the Kankakee River and should be considered a Water of the United States. Wetland 2 and Wetland 3, as described in the Report, directly abut Schurz Ditch, which is a perennial RPW (Schurz Ditch) which flows indirectly into a TNW (Kankakee River), and therefore are considered Waters of the United States.
