C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Fisher Ditch exhibits a defined bed and bank with an OHWM. Based on a review of aerial photos and a site inspection, it appears to have perennial flow. Fisher Ditch outlets directly into the St. Joseph River. The St. Joseph River is a perennial river that becomes a TNW regulated under Section 10 of the RHA downstream of the dam in Berrien Springs, Michigan. The section of the St. Joseph River within the project review area, and its tributary, Fisher Ditch, are RPWs and therefore are considered waters of the United States.
