### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

Therefore, the wetlands directly abut Beyer Brady Ditch. As described above, the Beyer Brady Ditch has perennial flow and exhibits a defined bed and bank with an OWHM. According to local drainage maps, Beyer Brady Ditch outlets into Pike Lake, which is hydrologically connected to the Tippecanoe River, a tributary of the Wabash River, a TNW.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The site was inspected on March 27, 2018 for verification of the wetland boundaries. The Corps concurs with the wetland delineation report (December 5, 2016, Cardno). The area labeled "artificial basin" does not meet wetland criteria and appears to be a former detention basin excavated out of upland. Stream 01 (Beyer Brady Ditch) has a defined bed and bank, exhibits an Ordinary High Water Mark, and has perennial flow. Wetland 04 directly abuts Stream 01 within the review area. The wetlands labeled 02, 01, and 03 form a large wetland complex and are labeled to identify different wetland types (01 = PEM, 02 = PFO, 03 = PSS). Beyer Brady Ditch is excavated out of this wetland complex; the wetlands directly abut the RPW off-site to the south of the review area. According to local drainage maps and the USGS NHD map, the wetlands and Beyer Brady Ditch flow into Pike Lake, which is hydrologically connected to the Tippecanoe River, a tributary of the Wabash River. The Wabash River is a TNW. Therefore, the features labeled Stream 01, Wetland 01, Wetland 02, Wetland 03, and Wetland 04 in the December 5, 2016 wetland delineation report are considered waters of the United States.
