Explain: **An isolated wetland is present within the review area. The wetland is situated within a depression in the landscape. I walked the perimeter of the wetland, and did not observe a potential surface or subsurface outlet from the**

wetland to connect it to a downstream water. The depression is surrounded by upland and receives sheet flow from the surrounding landscape. There is a pipe at CR 100 S, which appears to convey surface run-off/flow from the roadway towards the subject wetland. Based upon information gathered from the requestor and a review of resource maps, there are no known hydrologic connection or nexus between the wetland and downstream TNW. Therefore, the wetland is considered isolated. Isolated wetlands prior to the January 2001 Supreme Court decision in "SWANCC" would have been regulated under a nexus to interstate/foreign commerce based solely on the "Migratory Bird Rule" (MBR). Because the wetland within the review area does not appear to have connection to a downstream TNW, it is not considered a water of the United States.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**

I walked the perimeter of the wetland, and did not observe a potential surface or subsurface outlet from the wetland to connect it to a downstream water. The depression is surrounded by upland and receives sheet flow from the surrounding



landscape. There is a pipe at CR 100 S, which appears to convey surface run-off/flow from the roadway towards the subject wetland. Based upon information gathered from the requestor and a review of resource maps, there are no known hydrologic connection or nexus between the wetland and downstream TNW. Therefore, the wetland is considered isolated. Isolated wetlands prior to the January 2001 Supreme Court decision in "SWANCC" would have been regulated under a nexus to interstate/foreign commerce based solely on the "Migratory Bird Rule" (MBR). Because the wetland within the review area does not appear to have connection to a downstream TNW, it is not considered a water of the United States.
