850' northeast of the corner of North County Road 175 East and East County Road 175 North. This was consistent with aerial imagery that appeared to indicate that the area exhibited wetland characteristics. It was also noted that the area of investigation contained both Houghton muck and Kosciusko sandy clay loam, according to the NRCS's Web Soil Survey for Kosciusko County. Houghton muck is listed as a hydric soil for Kosciusko County. Given the results of our desktop review, the area would appear to meet wetland criteria. This was confirmed by our March 26, 2018 site inspection. Standing water was observed within the depression and cattails (*Typha* spp.) were observed on the eastern side of the wetland area. Hydrology for the wetland is driven by precipitation in the form of rainfall, snowmelt, and runoff from surrounding agriculture fields and East County Road 175 North to the south. Based upon our site inspection, review of the applicable USGS Topographic maps, and aerial imagery, there does not appear to be the presence of a hydrologic surface or subsurface connection between the wetland and downstream Waters of the United States. The elevation contours suggest that the wetland area is in a pronounced depression within the surrounding upland agricultural landscape and East County Road 175 North to the south. The USGS Topographic map did not indicate the presence of surface water (RPW, Non-RPW, or TNW) in the vicinity of the wetland, nor did we observe one during our site inspection. We did not observe a stand pipe or other structure that may serve as a conduit to downstream Waters of the U.S. We did not observe a berm or other man-made structure separating the wetland from a surface water. The wetland does not provide for interstate or foreign commerce, is not subject to commercial use currently, and will not be subject to commercial use in the future. In addition, we observed no evidence that suggests the wetland supports recreational use and there are no known species that require the wetland to fulfill their life cycle requirements.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The subject wetland was part of an alleged unauthorized activity investigation stemming from a complaint that was forwarded to our office by the Indiana Department of Environmental Management (IDEM). IDEM had received an anonymous complaint concerning the "removal" of a wetland approximately 850' northeast of the corner of North County Road 175 East and East County Road 175 North. During our March 26, 2018 site inspection we did not observe any work occurring, or having

recently occurred, on the property. Further, the observed wetland has no discernable hydrologic connection to a Water of the United States and is an isolated depression situated wholly within an upland agricultural landscape. No potential flow path or other potential surface or subsurface hydrologic connection to a Water of the United States was observed. Therefore, the wetland is located in a landscape position that precludes a hydrologic connection to waters that are part of the tributary system of the Tippecanoe River and should not be considered a Water of the United States.
