isolated waters. The USFWS National Wetland Inventory (NWI) did not indicate the presence of wetlands within the review area which is primarily mapped as Haskins loam on the NRCS's Web Soil Survey for Allen County. Section I, as described in the Wetland Delineation Report (Report) provided by Earth Source, Inc., is a wetland 0.08 acres in size located approximately 150 feet north of the storm water detention pond south of the review area. Based upon our site inspection and review of the applicable USGS Topographic maps, aerial imagery, and county drainage maps, there does not appear to be the presence of either a surface or subsurface hydrological connection between the wetland and downstream Waters of the United States. Section I is not separated by a berm or other man-made structure from a surface water. In a July 02, 2018, site inspection, the location of boundary stakes, placed by the consultant, were collected using our Trimble GPS unit. Section II, as described in the Report, is a wetland 0.27 acres in size stretching from the northern limit of the review area to the southern limit. The depression is likely a seasonally inundated depression fed by surface water runoff from the surrounding upland residential and commercial landscape. Review of the applicable USGS Topographic maps, aerial imagery, and county drainage maps did not indicate the presence of a potential flow path or other potential surface or subsurface hydrologic connection to a downstream Water of the United States; this was confirmed during our site inspection. Further, elevation contours suggest that the wetland area is contained in a depression within an upland landscape. Section II is not separated by a berm or other man-made structure from a surface water. Upon inspection of the consultant's boundaries, we did not agree with the western limit of Section II. Data points were collected and the approximate wetland boundary was walked using our Trimble GPS unit. Section II appears to be approximately 0.37 acres in size. For the purposes of this AJD, we will use the acreage we collected during our July 02, 2018 site inspection. However, we are aware of the limitations of our equipment in that our GPS unit is not survey grade and emphasize our data provides only an estimate of the approximate acreage of Section II. Neither Section I nor Section II provide for interstate or foreign commerce, are not subject to commercial use currently, and are not likely to be subject to commercial use in the future. In addition, there does not appear to be evidence that suggests the either wetland supports recreational use and no direct evidence was observed of known species that require the wetlands to fulfill their life cycle requirements.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The wetlands on the parcel have no observable hydrologic connection to a Water of the United States and appear to be isolated depressions situated wholly within an upland landscape. No potential flow path or other potential surface or subsurface hydrologic connection to a Water of the United States was observed. Therefore, wetlands Section I and Section II are located in a landscape position that precludes a hydrologic connection to waters that are part of the tributary system of the Little River and are not Waters of the United States.
