C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Aerial imagery taken in 2002, 2005, 2011, 2014, 2016, and 2017 and site photographs taken in April and June of 2018 suggest that the UNT to Graham McCulloch Ditch conveys water throughout the year. Our site inspection confirmed the presence of an Ordinary High Water Mark (OHWM) and a defined bed and bank.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The Unnamed Tributary (UNT) to Graham McCulloch Ditch (Section I) is a perennial RPW that exhibits an Ordinary High Water Mark (OHWM) and a defined bed and bank. Once the UNT reaches the southern end of the review area, the stream continues to flow south approximately 1 mile to its confluence with Graham McCulloch Ditch. Graham McCulloch Ditch flows approximately 3.3 miles west southwest to its confluence with the Little River (TNW). The Little River then flows southwest to its confluence with the Wabash River near Huntington, Indiana. Therefore, the UNT is an RPW within the tributary system of the Little River and is considered a Water of the United States.
