C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- If potential wetlands were assessed within the review area, these areas did not meet the criteria in the 1987 Corps of Engineers Wetland Delineation Manual and/or appropriate Regional Supplements.

 - Prior to the Jan 2001 Supreme Court decision in "SWANCC," the review area would have been regulated based solely on the "Migratory Bird Rule" (MBR).
- Waters do not meet the "Significant Nexus" standard, where such a finding is required for jurisdiction. Explain: **The subject wetlands were likely farmed for many years. Per our review of aerial photos, it appears farming was abandoned on the site between 1999 and 2005. Tribal Planning staff informed us a water line was installed along the western edge of the subject area between 1999 and 2005. This work could have blocked agricultural field tiles, allowing for the return of nearer-to-the-surface hydrology and leading to the slow re-formation of a wetland complex on the former crop land. This wetland is contiguous with a wooded wetland on the eastern side of the old field. The wetlands in the woods are classified as a forested/scrub shrub site in the NWI maps. The nearest possible drainage path from the wetlands to downstream waters is on the eastern side of the forested wetland where the complex connects to two small farm ponds that are connected by a shallow ditch. The easternmost farm pond is some 470 feet west of the ditch along Sheperd Road. We inspected adjoining properties and ditches along Remus and Sheperd Roads for a connection from the wetlands to Onion Creek which is a tributary to the Chippewa River which a major tributary to the navigable Tittabawassee River. Onion Creek was excavated and straightened as a County Drain many years ago. There were no watercourses, drainageways, or apparnt areas of overland flow from the wetlands to the ditches along Remus or Sheperd Roads. It appears that some storm flow or snow melt could flow overland from the farm ponds into a storm drain installed about 80 west of the eastern-most pond. Per Tribal records, this storm sewer runs directly south and outlets into the ditch along Remus Road. We inspected the ditches along Remus and Sheperd Roads and determined the ditches parallel/follow the contours of the roads and landscape and do not appear to cut through the slight elevation changes in the road/landscape. There was not an obvious downslope, uninterrupted, surface water connection from the ditches along Remus Road and/or Sheperd Road to Onion Creek. Tribal Planning staff informed us the Tribe developed the land just east of the subject wetland in the early 2000s, which included installation of the aforementioned storm sewer. We saw evidence of the development in aerial photos. .**
