to be isolated waters. The seven wetlands identified in the Report total an area approximately 2.98 acres in size. The USFWS National Wetland Inventory (NWI) did not indicate the presence of wetlands within the review area. The NRCS's Web Soil Survey for Elkhart County has mapped the review area as upland soils which primarily include Pits, gravel (Pmg) and Bristol loamy sand (Btx), which suggests that none of the identified wetlands were excavated out of wetlands existing prior to mining operations conducted onsite. Based upon our review of aerial imagery and information provided in the Report, approximately 37 acres of the review area is a former sand and gravel mine. A fallow agricultural field exists (approximately 10 acres in size) in the southwest portion of the review area. Large spoil piles and borrow pits remnant from mining operations conducted in the area were observed throughout the site. Review of the applicable USGS Topographic maps, aerial imagery, and county drainage maps did not indicate the presence of a potential flow path or other potential surface or subsurface hydrologic connection from the identified wetlands to downstream Waters of the United States; this was confirmed during our site inspection. Further, none of the wetlands identified within the review area were observed to be separated by a berm or other man-made structure from a surface water. None of the waters investigated within the review area provide for interstate or foreign commerce, are not subject to commercial use currently, and are not likely to be subject to commercial use in the future. In addition, there does not appear to be evidence that suggests that any of the wetlands support recreational use and no direct evidence was observed of known species that require the wetlands to fulfill their life cycle requirements.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The wetlands identified within the review area have no observable hydrologic connection to a Water of the United States and appear to be isolated depressions situated wholly within an upland landscape. No potential flow path or other potential surface or subsurface hydrologic connection to downstream Waters of the United States were observed. Therefore, wetlands Wetland A, Wetland B, Wetland C, Wetland D, Wetland E, Wetland F, and Wetland G are located in landscape positions that preclude a hydrologic connection to waters that are part of the tributary system of the St. Joseph River and are not Waters of the United States.
