northeast corner of the subject parcel immediately west of North 50 West. It was noted that the USFWS National Wetland Inventory (NWI) did not indicate the potential presence of a wetland in this area and NRCS's Web Soil Survey for LaPorte County mapped the area of investigation as Blount silt loam and Riddles loam; both non-hydric soils for LaPorte County. A datapoint was taken during a June 17, 2019, site inspection that confirmed the presence of a wetland in the northeast corner of the parcel approximately 0.35 acres in size (Datasheets included in Site Inspection Report). The USGS National Hydrography Dataset indicated the possible presence of a conveyance between the identified wetland area and the agriculture field to the east of North 50 West. The site inspection revealed no such outlet/conveyance beneath North 50 West to the east as indicated by the USGS NHD. Further, the wetland appeared to extend onto the property to the north, however elevation contours suggest the wetland is located in a landscape depression within the residential property to the north and North 50 West to the east. The observed wetland has no discernable hydrologic connection to a Water of the United States and is an isolated depression situated wholly within an upland landscape. The USGS Topographic map did not indicate the presence of surface water (RPW, Non-RPW, or TNW) in the vicinity of the observed wetland. Further, a berm or other man-made structure separating the wetland from a surface was not observed. The wetland does not provide for interstate or foreign commerce, is not subject to commercial use currently, and will not be subject to commercial use in the future. No evidence was observed that would suggest the wetland supports recreational use and there are no known species that require the wetland to fulfill their life cycle requirements.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The subject wetland was part of an alleged unauthorized activity investigation stemming from a complaint that was filed with our office. The complainant submitted a number of photographs depicting the amount of



water that had collected east of the constructed home and over top a constructed gravel driveway. Recent work involving the discharge of fill material to construct a driveway across the wetland area was observed. Additionally, the construction of a trench/ditch that the property owner indicated was a mechanism to aid in moving water off his property was observed. A stand pipe, or other structure, that would drain this water from either the east or west end of the excavated trench was not observed. No outlet/conveyance beneath North 50 West to the east was observed as indicated by the USGS National Hydrography Dataset. The observed wetland has no discernable hydrologic connection to a Water of the United States and is located in an isolated depression situated wholly within an upland landscape. No potential flow path or other potential surface or subsurface connection to a Water of the United States was observed during the site inspection. Therefore, the wetland is located in a landscape position that precludes a hydrologic connection to waters that are part of the tributary system of the Kankakee River and is not a Water of the United States.
