CWA and, prior to the JAN 2001 Supreme Court decision in "SWANNC", this wetland would have been regulated under a nexus to interstate/foreign commerce based solely on the "Migratory Bird Rule" (MBR). This wetland lacked a nexus to interstate/foreign commerce per the factors in Section III.F of the Approved JD form and per factors in 40 CFR 328.3(a)(3)(c&d). This is based on the following: during a site visit on June 18, 2019 no continuous physical connection was observed between the subject wetland and a RPW and/or Non-RPW and ultimately a TNW; and Section I was determined to not be adjacent to other waters of the U.S. under Corps' regulatory jurisdiction. During our site visit, no continuous surface or subsurface connection to a waters of the U.S. from Section I was observed in the field. The identified swale does not meet wetland criteria as defined in the 1987 Delineation Manual and Midwest Regional Supplement, does not exhibit a defined bed and bank and was constructed/formed in non-hydric Bount silt loam soils. Therefore, this swale is not considered a waters of the U.S .

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The identified wetland (Section I) was determined by the District to be isolated (as defined in 33 CFR 330.2(e)) and not adjacent as defined in 33 CFR 328.3(c). Therefore, Section I is not a waters of the U.S. subject to jurisdiction under Section 404 of the Clean Water Act. The identified swale does not meet wetland criteria as defined in the 1987 Delineation Manual and Midwest Regional Supplement, does not exhibit a defined bed and bank and was constructed/formed in non-hydric Bount silt loam soils. Therefore, this swale is not considered a waters of the U.S .
