The USFWS National Wetland Inventory (NWI) identified the subject feature as a freshwater pond. During the site inspections, the pond was observed to be a primarily open water aquatic resource dominated by floating aquatic vegetation with some areas exhibiting emergent wetland characteristics in the southeast corner of the pond. The USGS Topographic map identifies the aquatic feature as a perennial pond. The USGS National Hydrography Dataset (NHD) indicated the possible presence of a conveyance from the pond to the east of Fir Road. The site inspection revealed no such outlet/conveyance beneath Fir Road to the east as indicated by the USGS NHD. In February 1996, our office determined the area immediately west of our review area to be an isolated wetland during the investigation of another complaint of unauthorized activities (Corps File Number: 1996-171-607-0GC). Documentation from that investigation also identifies the pond subject to this review as an excavated pond; corroborating the findings of our July 17, 2019, and August 26, 2019, site inspections. The USDA-NRCS Soil Survey maps the area of the pond as Urban land-Gilford (UeqA) complex, a partially hydric soil for St. Joseph County, and is consistent with the soils mapped in the wetland area to the west of the review area. This evidence would suggest the pond may have been dug within a wetland in the past. A culvert was observed along the western boundary of the property terminating in an excavated channel between the wetland area to the west of the property and the observed pond. Though no water was observed flowing through the channel at the time of the site inspections, it would appear that water from the wetland area west of the review area may flow east through the observed culvert, through the excavated channel, and into the pond during large precipitation events and/or times of above average precipitation. The observed pond has no discernable hydrologic connection to a Water of the United States. The USGS Topographic map did not indicate the presence of a surface water (RPW, Non-RPW, or TNW) in the vicinity of the observed pond. Further, a berm or other man-made structure separating the pond from a surface water was not observed. The pond does not provide for interstate or foreign commerce, is not subject to commercial use currently, and will not be subject to commercial use in the future. No evidence was observed that would suggest the pond supports recreational use.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The subject aquatic resource was part of an alleged unauthorized activity investigation stemming from a complaint that was filed with our office. No outlet/conveyance beneath Fir Road to the east was observed as indicated by the USGS National Hydrography Dataset. The observed excavated pond has no discernable hydrologic connection to a Water of

the United States. No potential flow path or other potential surface or subsurface connection to a Water of the United States was observed during the site inspection. Therefore, the aquatic resource is located in a landscape position that precludes a hydrologic connection to waters that are part of the tributary system of the St. Joseph River and is not a Water of the United States.
