Lake Erie). Consumers Energy has owned the land for many years and allowed tenant farming on the land. The land has been routinely pumped to enable farming and pumping is basically a normal circumstance on the land. Consumers deactivated the Whiting Plant and during this process farming (and pumping) ceased pending sale of the property. New owners requested Corps JD in order to find out if they needed permits to begin farming the land again. Lake Erie is at record high levels (~2.5 feet above average) and subject area is presently subject to inundation and/or hydrology near the surface and exhibits growth of typical marsh vegetation. Resumption of pumping will remove the hydrology. Per guidance on normal circumstances and guidance regarding agricultural lands, we are not asserting jurisdiction over the subject property with caveat that removal of any portions of the levees could require a reassessment of jurisdiction.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
