feature excavated in uplands that would convey storm water from the Prestwick Subdivision storm water system to the pond north of the review area. The drainage feature was observed to originate at a storm sewer outfall along the north side of Prestwick Road. Review of historical aerial imagery from 1965 does not provide evidence that would indicate the presence of a stream or other potential conveyance in the area prior to the development of the golf course and residential development in the vicinity of the review area. Based upon the site inspection, review of applicable USGS Topographic maps, and county drainage maps, there is no evidence to suggest that the linear drainage feature conveys more than low volume/short duration flow in response to precipitation events and annual snow melt. The NRCS Web Soil Survey indicates the site having hydric soils, however, review of the 1965 aerial does not indicate the presence of a wetland in the surrounding area. Any potential wetlands present within the review area were likely drained and/or altered prior to the promulgation of the Clean Water Act.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
