Wetland	1	acre(s)	(b)(1) Non-adjacent wetland.	There are no tributaries near the wetland I, the closest identified tributary is 0.4 miles south of the wetland location. The geographic location of the wetland in relation to the tributary does not meet wetland adjacency criteria since the wetland does not abut an (a)(1)-(a)(3) water and is not physically separated by a natural feature from an (a)(1) - (a)(3). The wetland is also not physically separated from an (a)(1) - (a)(3) water by an artificial structure, dike barrier, etc., that has a direct hydrologic connection, this is based on the site review. The wetland is also not inundated by floodwater in a typical year from an (a)(1) –(a)(3) water, the wetland is located outside the mapped floodplain. Based on the FEMA flood map, this area is mapped as an area with no flood hazard.. Based on the geographic distance and annual flood chance, wetland not be subject to inundation by flooding in a typical year.
