B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: Based on observed vegetation and lack of sufficient hydrology, the property in question, a 0.77 acre parcel platted as Lot 8, does not meet Corps criteria for a wetland and is, therefore, not within Federal jurisdiction.
