Road 18 at the southern end of the applicant's parcel; it is mapped as PEM1C (Palustrine Emergent, Persistent, Seasonally Flooded) on the NWI. It has no inlet/outlet and likely collects water from surface runoff from the adjacent roadway and from land to the north, which is higher in elevation; this wetland is isolated with no observed surface connection to an RPW or non-RPW; it may have been historically constructed in hydric soils to serve as a detention basin for agricultural runoff. A second area that was viewed during this inspection is situated just north of the PEM1C wetland, and to the south of the applicant's residence; the area is mowed and maintained as a lawn, and has been for several years (prior to 1999). A portion of this area was recently scraped, creating a shallow swale approximately 50 foot long by 20 foot wide. The owner stated that he performed the work in an attempt to improve drainage in his yard, which tends to hold water following significant rain and thaw events. He excavated the swale in hopes that it would allow water to drain more quickly, south into the PEM1C wetland. Soils within this area are mapped as Rensselaer loam, 0 to 1 % slopes (hydric), however, there was no vegetation growing within the scraped area; it is essentially a shallow "muddy area". Though hydrology was present and soils within this area are mapped as hydric, due to the lack of vegetation, and primarily, by the fact that this area has been maintained as a lawn for several years (17+ years), it is my opinion that this area does not meet the definition of a wetland.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The approximate 0.4 acre wetland on site (PEM1C) is an isolated/non-jurisdictional wetland under the CWA and, prior to the January 2001 Supreme Court Decision in "SWANCC", the review area would have been regulated under a nexus to interstate/foreign commerce based solely on the "Migratory Bird Rule" (MBR). The wetland lacked nexus to interstate/foreign commerce per the factors in Section III.F of the Approved JD form and per factors in 40 CFR 328.3(a)(3)(c & d). This is

based on the following: during a site visit conducted on June 21, 2016, no continuous physical connection was observed between the wetland and an RPW or non-RPW and ultimately a TNW. The area situated between the wetland and the applicant's residence does not meet the criteria for a wetland, and is therefore, upland (non-wetland).
