C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

During the site visit, water was observed flowing within this drain. Natural Drain #4 flows into the Saint Mary's River (a RPW) and then into the Maumee River (a TNW).
- Tributaries of TNW where tributaries have continuous flow "seasonally" (e.g., typically three months each year) are jurisdictional. Data supporting this conclusion is provided at Section III.B. Provide rationale indicating that tributary flows seasonally: The on-site portion (110 linear feet) of the labeled "Drainage Feature" hydrologically connects with the off-site

labeled Drainage Features (692 linear feet and 380 linear feet) and is piped, through culverts, into Natural Drain #4 (a RPW). During our site visit, these drainage features were determined to have an Ordinary High Water Mark and defined bed and bank. Water was flowing in the off-site portion of the drainage feature near the identified culverts during our site visit. Since this drainage feature has an OHWM, defined bed and bank, and water was observed within this drainage feature during our site visit, it appears this drainage feature has flow seasonally and during storm events. This drainageway flows off-site through two culverts, into its connection with Natural Drain #4 (a RPW).
