**Wetland W-01, as described in the Wetland Delineation Report (Report), is a forested wetland approximately .15 acres in size and is located immediately north of the existing Greenway Substation. The USFWS National Wetland Inventory (NWI) indicated the potential presence of a forested wetland within the review as a component of a larger forested wetland complex that extended north and east outside of the review area. Wetland W-01 appeared to extend north outside of our review area (20191212\_0003.jpg), however, the larger wetland complex, which Wetland W-01 appears to be a component of, was determined to be isolated in a December 30, 2010, letter from our office (LRE-2010-00776-146). Review of the applicable USGS Topographic maps, aerial imagery, and county drainage maps did not indicate the presence of a potential flow path or other potential surface or subsurface hydrologic connection from the identified wetland to a downstream water of the United States; this was confirmed during the site inspection. Further, the wetland identified within the review area was not observed to be separated by a berm or other man-made structure from a surface water. The wetland investigated within the review area does not provide for interstate or foreign commerce, is not subject to commercial use currently, and is not likely to be subject to commercial use in the future. In addition, there does not appear to be evidence that suggests that the wetland supports recreational use and no direct evidence was observed of known species that require the wetland to fulfill their life cycle requirements.**

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The wetland identified within the review area has no observable hydrologic connection to a water of the United States and appears to be located in an isolated depression situated wholly within an upland landscape. No potential flow path or other potential surface or subsurface connection to downstream waters of the United States were observed. As discussed above, an Approved Jurisdictional Determination describing the aquatic resource as isolated was submitted to EPA for review on December 06, 2010; EPA concurred with the isolated determination. Site conditions have not changed and the wetland was still determined to be isolated per the recent site inspection. Therefore, Wetland W-01, as described in the Report, is located in a landscape position that precludes a hydrologic connection to waters that are part of the tributary system of the Kankakee River and is not a water of the United States.
