Private Pond	0.13 on-site	acre(s)	(b)(8) Artificial lake/pond constructed or excavated in upland or a non-jurisdictional water, so long as the artificial lake or pond is not an impoundment of a jurisdictional water that meets (c)(6).	There are no tributaries near the pond identified as Private Pond, the closest identified tributary is 0.3 miles west of the pond location. The geographic location of the pond in relation to the tributary does not meet wetland adjacency criteria since the wetland does not abut an (a)(1)-(a)(3) water and is not physically separated by a natural feature from an (a)(1) - (a)(3). The Private Pond is also not physically separated from an (a)(1) - (a)(3) water by an artificial structure, dike barrier, etc., that has a direct hydrologic connection, this is based on the site review. The Private Pond is also not inundated by floodwater in a typical year from an (a)(1) -(a)(3) water, the Private Pond is located outside the mapped floodplain. Based on the FEMA flood map, the floodplain for the closest tributary is mapped as a 0.2% annual chance flood hazard or 500 year flood event. Based on the geographic distance and annual flood chance, the Private Pond would not be subject to inundation by flooding in a typical year.
