C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Lake of the Woods is a permanent waterbody that exhibits an OHWM. Approximately 105 linear feet of lake shoreline is present within the review area. A review of topographic maps, aerial photography, soil surveys, and USGS NHD data confirms that Lake of the Woods is a permanent waterbody that contributes perennial flow as part of the tributary system of the St. Joseph River, a Section 10 Traditional Navigable Water. There are no other potential waters or wetlands present within the review area. The Corps' regulatory authority under Section 404 of the Clean Water Act is limited to the OHWM of Lake of the Woods.
